

I've often wondered whether being a loner is an automatic requirement for being an alcoholic. I've always been a loner, and so, I have found, have many others I've met in the program.

I tried to examine my preference for loneliness and came to the conclusion that I was guilt-ridden about my hiding bottles all over the place and about my heavy drinking and blackouts.

A.A. taught me that I didn't have to be lonely any

more. When my desire to drink in secret became less and finally vanished, I lost that sense of guilt and a load was taken off my mind. But it didn't make me suddenly gregarious and outgoing. I guess I'll always be a bit of a loner. I wish I could be like some characters I see on TV-totally outgoing and spontaneously funny and talkative.

Well, I guess I'll never be like those people, but I've discovered that there's a difference between being a loner and being lonely. I'm definitely lonely no more. I can talk to people at home and at meetings, though I still find I'm rather distant from the crowd that always

#### The Fountainhead

"I joined a group that devotes its closed meetings to Step discussion. Most of the members had their own concepts of a personal God; the atmosphere of faith surrounding me was so marked that I thought at times I was on the point of joining it. I never did. And yet I found the Steps revealing new depths of meaning with each discussion.

"In Step Two, the 'Power greater than ourselves' meant A.A., but not just the members I knew. It meant all of us, everywhere, sharing a concern for each other and thereby creating a spiritual resource stronger than any one of us could provide. Another woman in my group believed that the souls of dead alcoholics, including those of times before A.A. contributed to this fountainhead of goodwill. The thought was so beautiful that I wished I could believe it, too."

Gratitude is a must for us—not only feeling grateful, but showing we are grateful. But how does one ever show true gratitude for A.A.?

As grateful alcoholics learning to live with a subtle, progressive and lethal illness, we have a fighting chance on a day-to-day basis to be of some use to ourselves, our families and our communities. We may even achieve magnificent and beneficent things if we choose.

The grateful A.A. member learns bit by bit what life is all about. We learn to live without lies, without conning people, and especially, without trying to be somebody we're not. In essence we unlearn all the "skills" we had developed in order to justify our addictive behavior.

Then, too, grateful alcoholics normally attend several meetings a week; to let others know we care, to welcome the newcomer with friendship and understanding, as well as to to pass on the message of how

to live without taking a drink.

Grateful A.A.s know that we must give away the priceless gift of sobriety if we are to keep it. The experience of the paradox of giving to receive occurs whenever we involve ourselves, at any level, in A.A. service. Some of us have special talents to offer as expressions of our gratitude, but we can all lovingly give away our sobriety in the simple act of sharing. We can also give our attention to others who would (and sometimes desperately need to) share with us.

And finally, grateful alcoholics thank their Higher Power. Many A.A. members develop a systematic daily spiritual program. They discipline themselves to seek God through prayer and meditation, to achieve conscious contact, and thus achieve an understanding of God.

But if adequate thanks sometimes seem beyond our capabilities, one can simply say, "Thank You for what You have given, for what You have taken away, and for what You have left me.

#### A.A. and the IRS


Every April as the 15th rolls around, the General Service Office receives several letters asking whether contributions to A.A. are tax deductible. Our GSO controller comes up with the following advice:

"Contributions to an Å.A. group central office are tax deductible if the entity is exempt from paying Federal income taxes under Section 501(c)3 of the Internal Revenue Code. Contributions made directly to the General Service Board of A.A. are deductible under that section of the code.

"The internal Revenue Code has no provision under which the board could apply for tax exempt status for all groups and other A.A. entities since each entity is autonomous in financial matters, as in all other ways. Donations to A.A. groups are not deductible unless the group has filed the proper application with the local IRS office and has been individually evaluated by that office. Some tax examiners may make exceptions if the proof of contribution is presented, but that is strictly up to the individual tax examiner.

"Travel expenses to conventions and registration fees are never deductible, because the government does not consider them to be donations."
