N.C. Mountain Central Office Elects New Board Members

Minutes of August Central Office Meeting.

The N.C. Mountain Central Office held its regular meeting on August 9 at Grace Covenant Presbyterian Church, Asheville. In attendance were: Dave A., C.O. Chairman (Acceptance Group); Bob K., C.O. Co-Chairman (Common Sense Group); Jack D., C.O. Treasurer (Grace Group); Bob V., C.O. Office Manager (Acceptance Group); Alan W. C.O. Secretary and Editor, *Mountain Doin's* (Happy Hour Group); Molly W. C.O. Trustee (Grace Group); Jerry P., C.O. Rep. (Cumberland Group); Cha Cha D., C.O. Rep. (Grace Group); Bob P., C.O. Rep. (Grace Group); Marshall D. acting C.O.Rep. (Hendersonville Group).

The meeting opened with the reading of the minutes of the previous Central Office meeting. The min-

utes were approved as read.

The Treasurer, Jack D., gave a financial report and explained the details of the July report (as published in the September, 1998, *Mountain Doin's*). He also mentioned the fact that Central Office had received the sum of \$2,000 from an A.A. member's estate, and since a financial gift to any single group cannot exceed \$1,000, he recommended that the remaining \$1,000 should be forwarded to the General Service Office. A motion was made to that effect and passed.

The Treasurer also reported on the Central Office's tax-exempt status, and added that it had been decided that the Central Office prudent reserve should be \$4,000. After some further discussion of various aspects of Central Office financial matters, Chairman Dave A., turned the meeting to new business.

Among matters discussed was the suggestion that Office Manager, Bob V., be granted a week's vacation, since he has not had one since becoming Office

Among the many duties are: holding meetings with District G.S.R.; helping obtain group information; keeping

G.S.R.s informed about Conference activities; keeping Groups informed about Conference-approved books and pamphlets, including *The Service Manual* and *Box 4-5-9*. Many other duties are presented on pages S55—S57 in *The Service Manual*. Altogether, a D.C.M.'s job is demanding but incredibly rewarding in giving back to A.A. some of what the program has done for us.

Al-Anon and A.A.—The Ties are Close, but Apart

The Al-Anon Family Groups and Alcoholics Anonymous have a unique kinship formed on the twin anvils of alcoholism and recovery through A.A.'s Steps, Traditions, and Concepts. Naturally drawn together by their common ties, the two Fellowships nonetheless have differing purposes: In A.A. our primary purpose is to stay sober and to help others recover from alcoholism: in Al-Anon members seek to understand and cope with the effects of someone else's drinking on themselves and to help the families and friends or alcoholics. Even though both Fellowships are concerned with the consequences of alcoholism-and although Al-Anon's program of recovery is based on an adaptation of A.A."s-historically they have functioned closely but not in each other's shadow. This separate functioning has served both A.A. and Al-Anon well. A.A.'s policy of "cooperation but not affiliation," in the spirit of Tradition Six, was recognized circa 1951, when the first Al-Anon service office opened its doors (Pass It On, page 359). And so, each entity has its own General Service Board, Conferences, publishing company, and directory; each has further established its own services and

Intergroup or Central Offices.

A question sometimes asked is, Can a group be affiliated with both A.A. and Al-Anon? The response, noted in the A.A. Guidelines on the Relationship Between A.A. and Al-Anon: "It is suggested that they not be combined, but remain as separate groups. This enables both Fellowships to function within their Twelve Traditions and to carry their messages more effectively. Thus, the group name, the officers, and the meetings should be either A.A. or Al-Anon, but not both." The Guidelines further suggest, "Whether open or closed, A.A. group meetings are conducted by A.A. members. At open meetings, non-A.A. members may be invited to share, depending on the conscience of the Group." Certainly all are welcome to attend open meetings of both A.A. and Al-Anon groups.
