Central Office - What We Do and Why We Need Your Help

Because of the events over the past several years I thought that it might be a good idea to answer some questions you may have and try to answer the specific question, "why should I support Central Office/Intergroup?"

What is North Carolina Mountain Central Office/ Intergroup's mission?

The mission of the North Carolina Mountain Central Office/Intergroup Internet website is to support the groups of Districts 70, 71 and 80 in their pursuit of the primary purpose of Alcoholics Anonymous.

How does your Central Office/Intergroup operate?

All groups in Western North Carolina are entitled and encouraged to have a Central Office Representative (COR) to express the group's conscience, views and desires at the quarterly Central Office/Intergroup meeting.

COR meetings will be held on a rotating basis in each of the three districts beginning in April in District 71. Intergroup meetings are an open forum for all A.A. members.

Financial support of NCMCO/Intergroup is purely voluntary and is not required for any group to have a representative and a vote.

It is the Central Office Board's responsibility to outline and monitor the NCMCO operations and activities in accordance with the By-laws of the North Carolina Mountain Central Office and the desires of the member groups.

How is North Carolina Mountain Central Office/ Intergroup financed?

- Group contributions
- Individual contributions from Alcoholics (A.A. members only)
- Sale of Conference and Non-Conference approved literature.

A brief financial statement is published monthly in the Mountain Doin's newsletter and lists all group contributions. Detailed financial reports are presented at the quarterly Central Office Representatives/ Intergroup meeting. If you have a question about contributions, call or email the Central Office manager.

What happens at the North Carolina Mountain Central Office?

12 Step Calls

The Intergroup Office maintains a listing for AA in all local telephone directories of each District. AA volunteers answer the phones, and when calls come in from individuals looking for help, the volunteers contact AA members from a twelve-step list maintained in the office and arrange for AA members to call on individuals seeking help from problems with alcohol. Individuals seeking help for other problems are referred to the appropriate programs or agencies.

Information

The North Carolina Mountain Central Office is the clearinghouse for information and logistical support between A.A. members, groups, local and Area committees, General Service Office in New York and the community at large.

Teleservice

When the Central Office is closed, individual A. A. members can get meeting information and locations, Also, our answering service and after hours' operators provide the referral service for alcoholics in crisis. AA Volunteers return calls to the alcoholics in crisis.

Mountain Doin's

Mountain Doin's, the Central Office/Intergroup newsletter, is published and distributed to all groups, meetings, and subscribing individuals with the help of volunteers. It contains Central Office/Intergroup financial reports and other A. A. news of interest to the three districts.

Where and When

North Carolina Mountain Central Office/Intergroup maintains a list of all known meetings in Western North Carolina. This meeting list is updated and published on a regular basis. There is also a meeting list of the corrections and treatment facilities meetings and information at Central Office/Intergroup.

Lending Library

Central Office maintains a lending library of Public Information (PI) materials for the use of the member groups and District Committees.

Literature

North Carolina Mountain Central Office/Intergroup maintains an inventory of Conference and Non-Conference approved books and pamphlets for sale to A.A. members and the general public. Central Office is also a collection point for institutional literature (Big Books, 12 and 12's, Grapevine magazines, etc.) to be used by any correctional facility/treatment facility committee for 12 Step distribution in Districts 70, 71, & 80.

A.A. Committee Meetings

Central Office/Intergroup provides space for A.A. committee meetings by reservation.

Special Events

Central Office/Intergroup sponsors workshops on topics of interest to A. A. members.

Our Primary Purpose

As you may have seen in this issue, we are updating the 12-Step list for the three Districts under Central Office. As usual, this is an ongoing task yet some of the signs leave a considerable gap in the individual AA's willingness to give back even just a little of what we have been so freely given. A significant number of crisis calls to the service have not had a response from an alcoholic because one could not be reached or the operators have had to call 12 to 20 numbers listed before they finally resorted to calling one of the last resort contacts on the list.

What has happened to our Primary Purpose? Do we have any gratitude left for our sobriety or do we feel that now that we are sober we don't have to care about the sick and suffering alcoholic any longer? Is this why our recovery numbers are dropping off the scale. Have we forgotten what it was like, how we felt with that black hole in our guts before we were given the gift of sobriety from our higher power? Is it too much trouble to be available to take a call from someone who could be at the moment of surrender and needs a little encouragement to get over the hump?

Is it time to look back to where we have come from and realize the gift we have been given, how much our lives have improved over time, and put that gratitude into action? Service work is the key to our survival and 12-Step work is the most important service work we can do. Remember that we are given a reprieve based on our spiritual condition. What condition is yours in?
