Service Keeps Us Sober: Corrections

When I came into the program several twenty-four hours ago in Miami, my sponsor at the time was very strong on service as a way to maintain a healthy program. One of the areas he thought was particularly important was corrections work. So, early on, he marched me off to jail.

Having never been incarcerated, it was a bit daunting at first to find myself "behind bars," so to speak. However, that uneasiness was short-lived as I soon realized that they were drunks—just like me—who had circumstances that led them to involvement with the corrections system. My thinking, drinking, and many of my actions were no different. It was just a matter that I had been lucky enough to avoid their fate.

I encountered a variety of folks in the meetings. Some I suspected would fall prey to their disease at the first possible opportunity, but I also met some who seemed to have had major spiritual awakenings as a result of applying the program to their lives. I will never forget one inmate, a young man who said he would probably spend the rest of his life behind bars. He was at total peace and acceptance of that fact, which had come through step work. Needless to say, he was a major inspiration to me. His calm, peaceful demeanor defied logical explanation but is totally understandable from the program perspective. He was a free man having experienced the miracle of recovery.

Today, I take meetings into the Bumcombe County Detention facility in downtown Asheville. I have continued to see some miraculous results. I can cite two recent examples where inmates worked the steps with volunteers and had major, life-altering experiences. They are now carrying the message to their fellow inmates as a result.

Of course many—especially the younger ones (with more not yets to live through—will most likely continue to drink when they are released, but I feel I am planting a seed when I share my experience, strength and hope, which often seems to register, albeit briefly. I know one thing for certain: it is like rocket fuel for my recovery. It is also an excellent practice in letting go of outcomes and turning others over to the care of their Higher Power.

I feel very honored to be doing this service—so much so, I call the jail my home group. The gratitude expressed by the inmates and the power of the meetings is like nothing else I have experienced in recovery. You come to realize that they are really fine folks for the most part, afflicted with a vicious, cunning, powerful disease and I totally relate to them all.




