Central Office Positions Open in January

The Central Office General Committee (CORs and Board members) will be electing new Board members for 2-year terms beginning in January 2025: Chairperson, Alternate Chairperson, Secretary, Treasurer, and 12th Step Call Coordinator.

Here are the responsibilities and requirements for each position:

Chairperson

- 1. Shall preside at Central Office Board and General Committee meetings.
- 2. Shall see that all decisions of the Committees are acted upon.
- 3. Pursuant to specific authority given on occasion by the Committees, may sign and deliver contracts and other documents in the name of North Carolina Mountain Central Office Inc.
- 4. With the recommendation and approval of the Central Office Board, shall call for eligible people to stand for positions and appoint chairpersons of standing and special subcommittees.
- 5. May vote, bring motions, initiate and engage in discussion and debate at Central Office Board and General Committee meetings in accordance with Robert's Rules of Order for Small Groups as specified in the By Laws.
- 6. Shall have five years continuous sobriety.

Alternate Chairperson

- 1. Shall perform the duties of the Chairperson when requested by the Chairperson or in the case of their absence or inability to act, and shall preferably be interested in rotating to the Chairperson position if it becomes vacant.
- 2. Shall have at least five years continuous sobriety.

Secretary

- 1. Shall take minutes of all General Committee and Central Office Board meetings and submit to the Central Office within 14 days after the meeting.
- 2. Shall have at least five years continuous sobriety.

Treasurer

- 1. Shall have charge and custody of all funds of Central Office.
- 2. Accuracy of all financial records of Central Office.
- 3. Arrange for preparation and filing of all required tax returns.
- 4. Preparation of an annual financial report and an annual budget.
- 5. Preparation and presentation of monthly financial report to the Central Office Board and General Committee.
- 6. Shall have at least five years continuous sobriety.

12th Step Call Coordinator

- 1. Shall have responsibility for maintaining the 12th Step Call Volunteer list.
- 2. Recruits new volunteers.
- 3. Work with the Office Manager to keep the 12th Step Call Volunteer list information current.
- 4. Shall have at least three years of continuous sobriety.

(The Board will also be looking for a new *Mountain Doin's* Editor as the current Editor's suggested 3-year term has ended. This is a Board-appointed position.)

The Guy Who Ruined My Meeting

He's new, he comes in late and he disrupts everything. Someone should do something.



I find my seat at the front of the room, early as usual. I have long-term sobriety and still regularly attend meetings, most often here at my home group. The speaker starts to share and I'm instantly hooked, connecting and identifying with the speaker's story. I'm wholly absorbed, listening with rapt attention. And then Keith—new to the group—loudly shuffles in, late again, jostling past me in the crowded room, the oversized bag he's dragging around hitting me in the head. By now the speaker's spell is broken, and I'm furious with this inconsiderate guy who has once again ruined "my meeting."

Hurricane Helene and A.A. in WNC

Almost all of us experienced the fury of Hurricane Helene in one way or another. Some areas were barely affected while others completely destroyed. For days, many could not connect with family, friends, sponsors, sponsees. Other lost their homes, their livelihoods, their loved ones. Those who were able stepped up to volunteer at the numerous places that immediately began providing food, drinking water, supplies and hot meals, charging stations and wifi. I think we have all seen the very best in our fellow human beings, as we reached out for assistance while in turn helped our neighbors. Recovery – physical, emotional and spiritual – may take a long time. But the kindness and generosity of so many will never be forgotten. – Pam C.

Here are a few stories from local A.A. members...

We live in the Little Creek area of Burnsville, NC, near the Cane River. When Hurricane Helene moved through, we were left with no roads or bridges to get out. Many lost their lives and homes. We still have no power at day 25, and rough roads to travel.

I'm so grateful that I have been able to live the AA principles of Love and Service. I was unable to get to a meeting for three weeks and continued to be at peace by putting the AA program into practice. Helping those sick and suffering kept me sober and serene in a very devastating situation. I kept thinking of the early A.A. members who went off to war and stayed sober. Thank you God for the program of Alcoholics Anonymous and the opportunity to be of service.

One of the many kindnesses that were offered to me that I accepted from sober members following Hurricane Helene was the use of two dishwashers in one kitchen for two weeks of dirty dishes. And I was offered and accepted kind offers to take a shower in multiple members' homes.

I had former sponsors reach out to me to make sure I was okay, and offered cash and lodging. I had prayers and light offered from all over the world. I was welcomed graciously in meetings in Calabash, NC and the surrounding area.

Living in Mars Hill, being relatively unscathed, I went down to Marshall to see if I could be of any help.

The experience was overwhelmingly uplifting! Local paving equipment and excavating contractors were busy loading mud and debris into trucks and trailers, (all at their own expense) as residents, business owners and volunteers cleaned the same out of the structures still left standing. Hauling it to the local landfill. 70 loads a day I'm told. As contractors pulled out to run their own businesses, other equipment and volunteers from all over moved in, including 30 personnel from 264th Engineer Co., Fort Liberty, NC, and 80 personnel from 101st Airborne Division, Fort Campbell, KY.

With the town administration and maintenance folks busy with infrastructure and setting up temporary facilities operations, (Town Hall was completely wiped out, along with sewer and storm drainage.) local volunteers hit the ground running! They got the whole otherwise chaotic situation organized. Equipment and volunteer placement, food and personal protective equipment distribution. It all ran like a well-oiled machine!

I fell in to help at the Presbyterian Church, where folks were pushing wheelbarrows of mud to the street. The Marshall AA group met here for years. I sent a picture of the chairs from the fellowship hall piled on the street to be hauled to the landfill, to a fellow member, with the caption saying, "our sober a $_{-}$ sat a lot of days in these chairs."

I stayed and helped at the church for the two-plus weeks of clean up,

as volunteers from all over came and went, all pitching in shoveling and wheeling mud, pressure washing and re-pressure washing, removing drywall, carpet, mud-filled duct work and other watersoaked debris, all hauled to the street to be removed in the well-organized fashion previously mentioned. The town is in assessment stage now, determining what and how to rebuild.

In the last couple of days, someone planted pansies in the church planters. A sign of hope in a town that's down but not out.

I am so grateful that I can feel blessed by being just a tiny part of this, that I can recognize the unselfish contribution of others and how this selflessness has brought this devastated community to a place of hope.

God, I love AA! It has given me a life worth living! Rick G.

In June or July of 2020, Joyce and Trink started an outdoor meeting at the Nature Center next to the Swannanoa River in East Asheville. It was a 7 AM meeting. We met in the giant gazebo next to the municipal swimming pool. Some of you may have visited - we typically had 4 to 12 friends show up for these loosely structured meetings. Trink crafted a grab bag of topics to get our shares started. We'd open the meeting with the serenity prayer. Choose a topic from the bag, or share about your own personal topic, and the meeting would proceed. When all had shared enough, we closed the meeting with the "We" version of the serenity prayer. This year the meeting has shrunk to 6 or 8 attendees.

There was a big storm in 2022 that damaged the big gazebo. We moved down to a picnic shelter closer to the river for a year. Finally, we moved to the Soccer fields a little more upstream along the Swannanoa. We loved that meeting for about a year until Helene wrecked the soccer complex. This image was taken from our usual meeting spot at the Soccer Fields the Saturday after the flood. Our shelter is on the left, the soccer field on the right, the Swannanoa River back in its banks at the far edge of the picture:



The road to the shelter was impassable to vehicles. Many trees down on Azalea Road. We stopped meeting for the two weeks after the storm.

You are invited to join in our gentle, casually outdoor meeting, Tuesday and Thursday, 7 AM, at the picnic tables outside of Whole Foods. We hope to find another spot closer to the woods soon. One Day At A Time,



Keith continues to show up late, meeting after meeting, and I obsessively rehearse in my mind what I'd like to say to him. Being a "good AA," I know I need to practice love and tolerance, but this is a guy who's disruptive to the entire room. I mean, isn't it for the good of the group that he not be such a distraction? I pray for God's will and remind myself that it's OK to think like a jerk, I just can't act like one.

I'm going to celebrate 25 years sober and Keith overhears me telling the meeting secretary that I'll be taking a cake the following week. Excitedly, Keith tells me that we share a birthday—he'll be celebrating one year—and he asks me to present him with his cake. My heart softens a little for this stranger who I've made into my nemesis. "Of course, I'll give you a cake. It would be my pleasure," I hear myself say—not at all what I had been planning to say to this guy who's been driving me nuts.

That next week Keith shows up early to the meeting wearing a suit and tie. "This is a first," I mumble under my breath. The time comes to celebrate birthdays and he's up first. I present Keith with his one-year cake and he's beaming at me with pride and gratitude. He explains from the podium that it's been a tough year for him: he's been undergoing brain cancer treatment and waiting for a necessary hip replacement, which is on hold until his body is strong enough for the surgery. He adds that he rides his bicycle to the meeting in terrible pain, but even that's getting harder for him. Yet despite all his hardships, the caring and support he's found in the meeting has been his lifeline. And then he thanks me—and I'm reduced to tears, my heart full of compassion and humility.

It's been four months since Keith and I celebrated our birthdays together. I hit a 25-year milestone in my sobriety that day, but more important, I was reminded of my primary purpose and why I practice AA principles in all my affairs. The best part of this story: I now drive Keith to the meeting each week, insuring we both get there on time.

To Booth or Not to Booth

Tradition Eleven says our public relations policy should be based on attraction rather than promotion, which seems like a fairly straightforward suggestion.

However, the Tradition was put to the test at one of our Intergroup business meetings, which is regularly attended by more than 100 fired-up, opinionated, vocal alcoholics, after someone made a proposal to host and fund an AA literature booth in the healthcare section of our upcoming State Fair.

After the motion was made, there was a prolonged and heated discussion on what attraction vs. promotion meant. About half the members argued that having an educational booth with pamphlets should not be undertaken because that would be publicly promoting AA. And an equally boisterous group of members thought the booth was educational in nature and that we had an obligation to let the public know about our recovery program. They argued that even though AA members are anonymous, AA itself is not.

The difference in viewpoints became a contentious issue. Opinion,

testimony and passionate debate ensued for months. To add fuel to the fire, some members were afraid the volunteers manning the booth might be recognized, which would violate their personal anonymity. In short, this dispute was a mess. Hard feelings surfaced on both sides.

Eventually, we made the decision to go forward with the project, since more members believed that having a booth would be more educational than promotional and that some of the thousands of people attending the State Fair might be attracted to learn more about AA for themselves, their friends or their families.

You would have thought the issue was settled, but every year when Intergroup members must decide whether or not to make the effort and spend the money to host a booth at the State Fair, the same squabble erupts all over again, with the same result, based on the same Tradition.

All I can say is thank goodness our Traditions don't change. They continue to provide a channel to guide our well-intentioned but often contentious Fellowship.
